Sub: Extension of Recognition Certificate for the School under sub-rule (4) of rule 11 of Right of Children to Free and Compulsory Education Rules, 2009 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir/Madam,

With reference to your application dated **25-06-2026** and subsequent correspondence with the school/inspection in this regard, the term of Provisional (RTE) recognition accorded vide this office order No. DO/CRG/Prov/Recog/RTE/2022/1983, dated 28-02-2023 in respect of **Centre For New Learning, Bengtol, Vill- No. 2 Bengtol, P.O- Bengtol, Dist.- Chirang, BTC, Assam** for **Nursery to Class VIII** is hereby extended for another period of 3 (three) years w.e.f. **01-02-2026 to 31-01-2029**.

The above sanction is subject to fulfillment of the following conditions:

- (1) The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
- (2) The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2010 (Annexure II).
- (3) The School shall admit in class Nursery, to the extent of 25% of the strength of the class, children belonging to weaker sections and disadvantaged groups in the neighborhood and provide free and compulsory elementary education till its completion. Provided further that in case of pre-primary classes also, this norm shall be followed.

- (4) For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.
- (5) The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- (6) The School shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, caste or race, place of birth or any of them.
- (7) The School shall ensure:
- (a) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - (b) No child shall be subjected to physical punishment or mental harassment.
 - (c) No child is required to pass any board examination till the completion of elementary education.
 - (d) Every child completing education shall be awarded a certificate as laid down under Rule 23.
 - (e) Inclusion of Students with disabilities/special needs as per provision of the Act.
 - (f) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualification shall acquire such minimum qualifications within a period of 5 years.
- (8) The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- (9) The school shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
- (10) The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

- (13) The school is run by a society registered under Societies Registration Act, 1860 (21 of 1860) (Act under which Society is registered), or a public trust constituted under any law for the time being in force.

- (16) The school furnishes such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in the working of the school.

4. The order will not accrue any financial liability to the BTC authority.

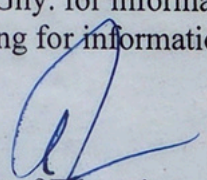
